**The MAHOGANY CHEST of MARGARET GRELIS (nee MURRAY)
Dublin 1860 to Coffs Harbour 2018**

Margaret Murray, was born in 1841 at Harold's Cross near Dublin, the daughter of **Martin Murray** and **Mary Kelly**. Martin Murray was a boatman on the Barges on the Grand Canal which connected Dublin on the River Liffey with the River Shannon.

In 1860 Margaret Murray at the age of 18 left Dublin and firstly travelled to Liverpool in England. On April 5, 1860, Margaret sailed from Liverpool on the 'Young America Carlisle' to the Colony of Victoria arriving in Melbourne on July 3, 1860. **Margaret Murray had with her a small Mahogany Chest with her clothes and belongings for the journey across the seas from Dublin, Ireland to Melbourne, Colony of Victoria.**

On her arrival she was first employed as a Domestic at **Castlemaine**. In 1862 she married **Constable Thomas Grelis** at St Francis Catholic Church, Melbourne. The chest was then carried to the different **Goldfield Police Camps at Daylesford, Glenlyon and Strathfieldsaye in Victoria.**

On Thomas's early death in 1875, Margaret at the age of 34 was left with seven children whose ages ranged from 11 years to one year. She moved into nearby **Bendigo** and in **1876** became the **Licensee of the Junction Hotel in Williamston Street**. For over 45 years she held **Hotel Licenses** at either **The Newmarket Hotel** on the corner of Nolan and Charleston Streets near the Saleyards, Bendigo, or **The Builders' Arms Hotel** in Mitchell Street, Bendigo.

Margaret retired in the early 1920s and died at the family home in **Myers Street** in 1926 aged 84 years. She could neither read nor write but according to Mr Quinn, an old Bendigonian who delivered goods to her hotel "*Woe betide any man who tried to diddle her of a penny as she could add up all the prices in her head.*"

The **Mahogany Chest** then became the property of two of her unmarried daughters, **Annie and Nellie Grelis**, who lived in the family home at Myers Street, Bendigo. Annie died in 1955 at age 91. Before Nellie's death in 1966 at age 92 the chest was given to her niece, **Mavis Grelis**, who was then residing at Bethlehem Home, Golden Square, Bendigo.

In 1977, **Mavis Grelis**, then aged 77 years, sent the chest to her niece **Rosemary Doherty** (nee Slattery), the daughter of her sister, Margaret. Rosemary and family had moved to Coffs Harbour in early 1977. Fortunately the chest was delivered to her by a Coffs Harbour Removalist, who noticed it sitting at a Removalist Warehouse in Sydney just addressed to '**Rosemary Doherty, Coffs Harbour**'. At this time in 2018 the **Mahogany Chest** after 158 years of travel is in Coffs Harbour, at the home of its grateful custodian, Rosemary Doherty, a great grand-daughter of Margaret Grelis nee Murray from Dublin, Ireland.

TROVE TREASURE

My 3xGGrandmother-in-Law, **Ellenor Seymour**, arrived in Victoria in March 1857 and married **William Reid Fitton** the following year. William died in 1871, leaving Ellenor with their five surviving children, four boys and one girl, aged between 2 and 12 years.

1873 must have been a tumultuous year for Ellenor. On 7th April she married **George Keyzer**, a widower with three children aged 7 to 14 years. On 10th April Ellenor applied for Letters of Administration on William's estate, which was granted 29th July. By 2nd September Ellenor had given birth to a son and was not married. **Seymour Sinclair Fitton Seymour** died 23 days later.

27th October saw the two youngest children placed in care; the third followed on 27th November and each record stated "*Father dead*". The fourth child was admitted on 10th January 1874 with the notation "*Mother dead*". The eldest boy is said to have absconded from the orphanage but no record has been found.

By 1878, all the children had left the orphanages, one had employment and the others were listed as having been '*removed by friends*'. These '*friends*' were **Uncle James Fitton** and maiden **Aunt Jane Fitton**. It is fair to assume that Ellenor had died but no record has been found.

Recently a Trove item caught my eye. It was a Family Notice referring to Ellenor's daughter, **Ellenor Martha Fitton**, who had married James **Hamilton Walker** "*at the bride's parent's residence, Bloomfield-street, Surrey Hills, Sydney*". To cut a long story short, I obtained the Marriage Transcription which indicated that **Ellenor Smith**, mother of the Bride, gave consent to the marriage. Witnesses were **Albert & Lucy Seymour**, Ellenor's brother and sister-in-law. Ellenor was not lost at all.

Further time spent on Trove elicited information that Ellenor was the wife of Henry Smith and that she had died in 1916. **Henry Smith**, residing at 'Seymour', Hanover Road, Hurstville, had died a year earlier. Ellenor's sons, William and Henry, lived in Sydney with their families and Funeral Notices for Henry Smith listed him as their father, which may have been a tribute to the man. I wonder too if the house name 'Seymour' was a tribute to Ellenor.

Is it fair to assume that Ellenor finally found happiness?

PS: The different spellings for **Ellenor Snr** and **Ellenor Jnr** are as in the records.

WHAT HAS CHANGED in 111 years?

Coffs Harbour Advocate (NSW: 1907 - 1942; 1946 - 1954), Tuesday 12 February 1907, page 2

‘EDITORIAL PARS:

“Progress” is always a good watchword, and if we were always satisfied with things “as they are,” we should never have any improvement. This way of putting it, we may say, is the end and aim of our ambitions in putting this journal before the public of this district. The public spirited amongst the inhabitants - those who are imbued with the “push” which means “business” are, of course, the cogs in the wheel of progress, and upon whose enterprise the future advance of the Coffs Harbour district will mainly depend. We are simply the chronicler of their doings, and it will be our part to see that the light of publicity shines in no uncertain manner on their efforts.

There is every indication that the future advancement of this fine district depends only on the manner in which its affairs are handled, and it will be our pleasure and pride to assist in every practical way a newspaper can to further its claims to such Government assistance and recognition as it undoubtedly deserves.

One of the most pressing questions requiring ventilation is that of landing passengers at the jetty. The present mode is barbarous and unsafe - a reflection on the steam-ship management and a disgrace to the Government. An authority which would sanction the erection of a jetty not sufficiently substantial to moor small steamers like those of the N.C.S.N. Co. must be wanting in discernment. The remedy is to take the bull by the horns and widen the jetty by at least one half. This would strengthen it and provide a safe roadway for pedestrian traffic. As at present, passengers landing risk their lives traversing the long distance, often in the dark, which is unavoidable. A shelter shed, too, is imperatively required, and should be erected at once, pending necessary alterations. This sounds urgent, but as Coffs Harbour residents know to their cost, the state of affairs is not overdrawn.

A substantial, steam launch in the meantime would be an easy solution to the difficulty. It is no joke for delicate women and children to be slung ashore in a basket, and it is only presuming on people's good nature to force them to submit to such treatment. It is not enough for the N.C.S.N. Co. to urge that this is unavoidable, and it is positively unfair to virtually intimidate people from coming here, which is actually the case. Besides, why should such an admittedly growing district be handicapped by a niggardly policy?

In the matter of mail communication, too, unsatisfactory happenings are not infrequent. As Marryat's character said, "it is precarious and not at all permanent." In fact, at times, we could cheerfully emulate the old bosom's expletives ourselves. This is not a bar harbour, in any sense, and our troubles are caused altogether by zealous parsimony, which inevitably brings, into play the Reform policy with its precious plea of retrenchment. One of the most acceptable forms of saving cash would be to retrench the House. They only work half-time, anyhow; but take all sorts of care not to forego their salaries. In 1905 the House sat three days during the first six months - 95 members drew £14,250 for three days work, and to make all square Mr. Carruthers "retrenched" necessary work, and the poorer-paid temporary hands were dispensed with. 1906 saw the same state of things, only more so, and now we find Ministers buttering one another and singing mutual pains of praise to celebrate their glorious achievements.

There is one piece of callous carelessness in connection with this slinging of passengers ashore, which passengers themselves are utterly unaware of until it is too late, and then it is touch or go whether there is not a serious accident. There is not even a safety hook to the line which is used to sling the basket. The public are treated on the basis of mere goods, where a jerk of the rope or a jar of the jib might land them in eternity. It is not right for a Government wharf to be thus handled. A private firm would be under inspection, and forced to provide a safety hook. A fatal accident may occur at any time, and after this warning, if such a preventable accident occurs, those in charge are to blame.' (Sic)

- * The Board of Health inspector was in Coff's Harbour during the week.
- * A meeting of the Agricultural Society will be held this afternoon.
- * The latest attacked small-pox patients exhibit the disease in a more virulent form.
- * A meeting of the Chamber of Commerce will be held tonight (Friday), at the School of Arts.
- * All accounts owing to the firm of **R. J. Smith and Co.** must be paid without delay to **W Seccombe.**
- * The rain prevented the Band from playing a programme in Fitzroy Park on Sunday afternoon last.
- * The first meeting of the new committee of the School of Arts will be held on Wednesday night next.
- * We believe a football match is to be played on the Coff's Harbour ground to-day. Local teams will be engaged.

- * Central Bucca Tennis Club announce their grand concert and dance at the Lower Bucca School of Arts on Wednesday, Aug. 6.
- * The district band will play a selection of music in Moonie-street (sic) tonight (Saturday), commencing at Bray's corner at 7.45 p.m.
- * **Mr. P. J. MacNamara** will hold an auction sale of land at Upper Orara, at his auction mart, on Sat., August 9. See advt.
- * It is the intention of the **Salvation Army** to open a branch at Coff's within a very short period. Two lady officers are to be stationed here.
- * A perfect avalanche of weddings are to take place in Coff's Harbour between this and Christmastide. We know of at least five that are sure to eventuate.
- * It is practically certain that **Mr. Briner** will have both Liberal and Labor opposition at the forthcoming State elections. It would be hard to prophesy the result.
- * The new Federal Postmaster General characterises the day labor system as a "fiddling" one, and states that any future works will be carried out by contract.
- * A boy on a Sydney street car had the following legend on his right arm: "Don't touch me, I have just been vaccinated; try Joe Gardiner's for your boots. How's that for advertising?"
- * **W. H. Clutton**, Liberal Organiser, will address a meeting of ladies on Monday next at the School of Arts under the auspices of the Coff's Harbour branch of the Women's Liberal League.
- * **Mr. Burnett** received a chatty note from **Randell Mann** at Belfast, Ireland. He tells of an enjoyable trip on the Continent, and a motor trip through England, Scotland and Ireland.
- * There was almost a panic among the huge-crowd waiting to be vaccinated at the Sydney Town Hall on Monday. It took half-a-dozen policemen to keep back the crowd. A number of women fainted.
- * **Dr. Wood** announces that having received a limited supply of lymph from the Government those who wish to avail themselves of free vaccination can be treated at his surgery at 3 p.m. on Mondays.
- * The winning numbers of Westmead Art Union are published in our business columns. As a large number of tickets were sold in this district holders should look at the numbers they hold and see if they are among the lucky ones.
- * **Bill Sonter's** next engagement is with **Jim Sullivan**, middleweight champion of England. The 'Argus' credits Sullivan with having gone 18 rounds with **Billy Papke**; if our memory serves us correctly he went 8 rounds with the Thunderbolt.
- * An hilarious drunk was perambulating Grafton-street on Wednesday night loudly proclaiming "I won't go 'ome till mornin'. Just then the "long arm" clutched him and he didn't "go 'ome till mornin"; in fact he brought a "quid" 'next mornin'.
- * On Sunday afternoon, at 3 p.m. the band will render the following programme (postponed from last Sunday) in Fitzroy Park: March "Gladiator's Farewell," selection "Songs of Sunday," gavotte 'Hearts and Flowers,' fantasia, "La Belle Savage," anthem, "Jerusalem My Glorious Home," march, "Liberty Bell," "God Save the King." A collection will be made for the Hammond relief fund.
- * The unusual rains and the mild weather so far prevailing this season may be looked upon as rather an ominous sign for the summer. A wet winter is frequently followed by a series of cold snaps right up to Christmas, and unless we get a month of showery weather then, the outlook for winter grass is a very poor one. The indications should warrant our preparing to hand-feed: we should grow sufficient for dry stock as well as for milking cows. (Sic)

VIV'S STORY

Our Society has a very lively member, **Viv Wolfenden** who was born in Tamworth in 1926 (also known as 'Viv the Morse-Code man'). You may have seen Viv around town playing beautiful music on his keyboard, sometimes at shopping centres or at various Nursing Homes. His skill using Morse code is amazing. He is great company and regularly entertains the researchers and monitors at the Family History Society in Rose Avenue with his stories. He wanted to share this story with you:

'Fourteen years ago in 2004 I visited a polling booth in Tahmoor and was informed that I was not listed on the roll. This was a great surprise as I had never requested removal from such. A short time later I tried to adjust this by phoning and asking why I was taken off the roll. The person attending my call was quite rude and replied "You are deceased" and hung up in my ear! Recently I decided to do some research on my Family Tree and came across some very surprising information: I was

deceased and my death had occurred on 24/8/2004. I got in touch with the Registry of Births, Deaths and Marriages and a staff member called Shannon treated me with the utmost respect. She advised me to write a letter explaining my predicament and requesting information about the person who supplied this information. She also advised asking for the records to be adjusted as I was still living and I could produce a Doctor's Certificate to prove it.'

- * **NSW State Archives and Records** have added 46,000 new images to its online collection taken from Gaol Photographic Description Books of 20 NSW Prisons. The records can be accessed for free at their website at www.records.nsw.gov.au. Each entry contains information about prisoners who passed through NSW prisons between 1870 and 1930 and includes extremely detailed information.
- * **Databases & Web Sites for NSW Family History Research:** Research and explore your NSW genealogy and family history online. Many of the databases, indexes and digitised records collections are free! The following links lead to birth, death, marriage and cemetery records for Sydney and other locations around NSW plus census records, incoming passenger lists, convict records and more. An interesting new feature is that instead of purchasing a digital certificate, researchers can get an image of the original registration form completed by the informant at a similar cost. - * **Victorian Midwives and Nurses** (from "Spreading Branches" at Narre Warren's Journal): If you have any nurses or midwives in your family and would you like to find out where they trained, when they were registered and where they lived, you can find all this information in the Victorian Government Gazettes. - * **Anglo-German Family History Society** is a self-help group with considerable expertise and resources and welcomes all those who are interested in researching the genealogy or family history of people from the German-speaking parts of Europe who have emigrated over the centuries and settled in England, Scotland, Wales and Ireland (North and South), and the neighbouring islands. - * **FamilySearch** has added many new records and images as well as indexing additional records including: additional 135 million new Records for **Denmark, Finland and Sweden** (church records, incl. birth, marriage and death records, confirmations, moving-in and moving-out records; court; tax lists; examination books and more; and an additional 29 million new historical records from **the Netherlands** incl. birth, baptism, marriage, death, church, notarial, army service and passenger list records and population registers.

Baptisms, Banns and Marriages, Burials and Parish Registers; and PDF images of **Scottish** records incl. Edinburgh Marriages 1595-1800; and much more including many from **Australia**.
